The duration of the services for each individual package is envisaged as four (4) months.

The second phase of consulting services shall include the construction supervision services of the schools in the below mentioned packages. The duration of services for each package is envisaged as twelve (12) months excluding defects notification period.

a) PACKAGE 1: (EU/FRİT-MEB-IEDB1/CS-02) AB/FRIT-MEB-IEDB1/DH-02 (Kahramanmaras /Hatay / Osmaniye Educational Facilities)

Consulting Services covering the Design Review and Construction Supervision for Educational Facilities for 11 schools in total as detailed below: Five (5) schools estimated to have a closed construction area of 35.000 m² in Kahramanmaras, Five (5) schools estimated to have a closed construction area of 35.000 m² in Hatay and One (1) school estimated to have a closed construction area of 7.000 m² in Osmaniye.

b) PACKAGE 2: (EU/FRİT-MEB-IEDB1/CS-03) AB/FRIT-MEB-IEDB1/DH-03 (Mersin/Konya/Kayseri Educational Facilities)

Consulting Services covering the Design Review and Construction Supervision for Educational Facilities for 11 schools in total as detailed below:. Five (5) schools estimated to have a closed construction area of 35.000 m² in Mersin, Five (5) schools estimated to have a closed construction area of 35.000 m² in Konya and One (1) school estimated to have a closed construction area of 7.000 m² in Kayseri.

c) PACKAGE 3:(EU/FRiT-MoNE-IEDB1/CS-04) AB/FRiT-MoNE-IEDB1/DH-04 (Bursa/İzmir Educational Facilities)

Consulting Services covering the Design Review and Construction Supervision for Educational Facilities for 10 schools in total as detailed below:. Six (6) schools estimated to have a closed construction area of 42.000 m² in Bursa and Four (4) schools estimated to have a closed construction area of 28.000 m² in İzmir.

d) PACKAGE 4: (EU/FRiT-MoNE-IEDB1/CS-05) AB/FRiT-MoNE-IEDB1/DH-05 (Kilis Educational Facilities)

Consulting Services covering the Design Review and Construction Supervision for Educational Facilities for 6 schools estimated to have a total closed construction area of 42.000 m² in Kilis

e) PACKAGE 5: (EU/FRiT-MoNE-IEDB1/CS-06) AB/FRiT-MoNE-IEDB1/DH-06 (Ankara/Istanbul Educational Facilities)

Consulting Services covering the Design Review and Construction Supervision for Educational Facilities for 12 schools in total as detailed below:. Six (6) schools estimated to have a closed construction area of 42.000 m² in Ankara and Four (6) schools estimated to have a closed construction area of 42.000 m² in İstanbul.

Consultants interested for one or more packages should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

- Experience in consulting services in the last five years,
- Experience in preparation of designs and design review and construction supervision of construction works contracts similar to the services defined above,
- Having no non-performing contract with Ministry of Education,
- Staffing and administrative capacity related to the consulting services.

The attention of interested Consultants is drawn to paragraph 3.14 of the World Bank's Procurement Regulations for IPF Borrowers (July 2016) ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. In case of a Joint Venture (JV), all members of the JV will be evaluated jointly for the purpose of short listing and shall be jointly and severally liable for the assignment and shall sign the contract in case of award is made to that JV group. Interested consultants should clearly indicate the structure of their "association" and the duties of the partners and sub consultants in their application. Unclear expression of interests in terms of "in association with" and/or "in affiliation with" and etc. may not be considered for short listing.

A Consultant will be selected in accordance with the Consultant's Qualification (CQS) method set out in the Procurement Regulations.
